**WHAT DOES NOT  
QUALIFY?**

- DUI
- Driving on Suspended License that is connected to other criminal charges
- Driving While Revoked
- Felony by Motor Vehicle
- Habitual Motor Offender
- Other County fines & fees
- Other Court fines & fees
- Out of State fines & fees
- If you are not eligible by the State of TN to restore your driving privileges
